Terms & Conditions

These are the terms and conditions on which we supply services to you. Organization of Entrepreneurial Artists LLC ("OEA"), the owner of thecreativewarehouse.com ("TCW") provides an online platform (the "Marketplace") where the seller of the artwork (the "seller" or "consignor") offers artwork to you for sale. You buy the artwork from the seller via the Marketplace.

Please read these terms and conditions (the "terms") carefully before you submit any order for artwork to the seller via the Marketplace. Please use the 'contact us' link if you think that there is a mistake in these terms or they require any changes.

We may revise these terms from time to time and we will give you notice of this when we do so by stating that these terms have been amended and updating the relevant date.

USER ACCEPTANCE

Organization of Entrepreneurial Artists LLC ("OEA"), and its website thecreativewarehouse.com ("TCW" or the "Website") grants permission to you to use the Website subject to the following Terms and Conditions, which may be updated by us on a regular basis and without notice. These Terms and Conditions constitute a binding agreement between OEA and you governing your use of the Website. By using and/or visiting the Website, you agree to both these Terms and Conditions and to the Privacy Policy (the "Privacy Policy"), which can be found on the TCW website homepage for review.

Before you may use or create an account on the Website, you must read and accept all of the Terms and Conditions and Privacy Policy. As you read this Agreement, you should also access and read any linked information. You are only authorized to use the Website if you agree to abide by all applicable laws and these Terms and Conditions. "Art Submissions" means images of artwork submitted by the Seller to TCW for display on the TCW website.

"Content" means information, data, software, audio, music, sound, photographs, graphics, video, chat, messages, files, ideas, text, Art Submissions and any other material contributed by Users to the Website.

"Seller" means the seller of artwork via the Website having signed the Seller Terms.

"User", "you" means Sellers and any users of the Website who contribute Content to the Website.

WEBSITE ACCESS

OEA grants you permission to use the Website as set forth in these Terms and Conditions, so long as: (i) you will not copy or distribute any part of the Website in any medium without TCW's prior written approval; (ii) you will not alter or modify any part of the Website other than as may be reasonably necessary to use the Website for its intended purpose (iii) you agree to the Terms and Conditions as set forth in this document, and (iv) your use of the Website as permitted is solely for your own personal use or on behalf of the Seller.

In order to access some features of the Website, you will have to create an account. You are not allowed to use another user's account without permission. When creating your account and user profile you must provide accurate and complete information. You are solely responsible for the activity that occurs on your account, and you must keep your account password secure. You may change your password at any time by updating your account profile page. Sellers are responsible for providing Art Submissions to TCW and TCW reserves the right at its discretion to select the Art Submissions for display on the Website.

The ideas, suggestions, opinions, comments, and observations made by Users and any other Content posted by Users on the Website are not endorsed by TCW, and TCW makes no guarantee regarding the reliability, accuracy, or quality of any Content that is posted on the Website.

Sellers providing Art Submissions warrant that the Art Submissions provided meet these Terms & Conditions, and that they are liable to TCW and indemnify TCW for any breach of that warranty. This means Sellers will be responsible for any and all loss or damage TCW suffers as a result of breaching this warranty.

You acknowledge that you will evaluate and bear any risks related to your use of any Content, including any reliance on the accuracy, completeness, or usefulness of such Content. All Content posted to the Website by Users is the sole responsibility of the person who originally posted the Content, and your sole recourse for any damage you may suffer as a result of this Content shall be to such individual.

While TCW makes reasonable endeavors to validate the legitimacy of all Art Submissions before showcasing and selling work on the site, the Seller providing the Art Submissions, is ultimately responsible for the accuracy of the Art Submissions, and your recourse for any damage you may suffer as a result of such reliance on the Art Submissions is to the Seller.

The Content on the Website, including any Art Submissions, created and posted by TCW and the trademarks, service marks and logos contained therein ("Marks"), are owned by or licensed to TCW, subject to copyright and other intellectual property rights under the United States and foreign laws and international conventions. We also have the right to disclose your identity to any third party who is claiming that any Content posted by you or Art Submissions provided to TCW constitutes a violation of their intellectual property rights, or of their right to privacy.

COPYRIGHT INFRINGEMENT

TCW requires Users and Sellers to respect and honor all copyright laws. In your use of and interactions with the Website, you may not post, modify, distribute, or reproduce in any way any Content, including any Art Submissions, that is copyrighted material belonging to others, without obtaining their prior written consent. TCW reserves the right to remove any Content and/or Art Submissions if we believe it may infringe the copyright rights of others. TCW also holds the right to terminate the accounts of users who we believe to be infringing any copyright laws or these Terms and Conditions.

If you believe that your work has been copied or posted on the Website in a way that constitutes copyright infringement, you will need to send a written communication that includes substantially the following:

- 1. Identification of the copyrighted work claimed to have been infringed, or, if multiple copyrighted works at a single online site are covered by a single notification, a representative list of such works at that site.
- 2. Identification of the material that is claimed to be infringing or to be the subject of infringing activity and that is to be removed or access to which is to be disabled, and information reasonably sufficient to permit TCW to locate the material. TCW is an intermediary in the transaction between buyers and sellers. When you purchase artwork offered by a seller on the Marketplace, the contract for the sale of the artwork is concluded directly between you and the seller. It is the responsibility of the seller to perform its obligations under the terms of any contract created with you when you purchase artwork on the Marketplace.

To purchase artwork via the Marketplace, you must either create an account or input the personal and contact details that we request from you before you are allowed to contact the seller. You can find details of how we use your personal information in our privacy policy.

You may only purchase artwork from the Marketplace if you are at least 18 years old.

Except as otherwise expressly provided in these terms, we are not the agent, intermediary or other representative of the seller. We are not a fiduciary or trustee of the seller. We are not your agent for any purpose.

TCW reserves the right to refuse, modify, or terminate all or part of the services we offer to anyone for any reason at our discretion.

THE ARTWORK

The images of the artwork on the website are for illustrative purposes only. Although we have made every effort to display the colors accurately, we cannot guarantee that a device's display of the colors accurately reflects the color of the artwork. Although we have made every effort to be as accurate as possible, given the bespoke, handcrafted nature of much of the artwork sold on the website, the exact size of artwork may differ from piece to piece and from the official sizes, weights, capacities, dimensions and measurements indicated on our website. TCW is not held responsible for any issues with the artwork. The buyer is responsible for resolving problems with the artwork directly with the seller.

TCW is not responsible for loss or damage you suffer for any purchases via the Marketplace. It is the seller's responsibility for loss or damage to you limited to the amount you paid for the artwork via the Marketplace.
